Frailty in the older adult is a distinct condition from the normal aging process, and has been associated with poor outcomes from disease, increased fall rates, increased hospitalizations, institutionalization, development of disability, and increased death rates. Frailty is found more in females, ethnic minorities, and in persons with lower socioeconomic status. with a cost that has been estimated at approximately \$1 billion per year. Hospitalization increases the severity of frailty with each inpatient day. Gain an awareness of the syndrome of frailty, as well as the possible treatment modalities and interventions that may ameliorate this condition.

A4 The Child with Allergic Rhinitis: When It's an Allergy and When It's Not 25% Rx

The current prevalence of allergic rhinitis in children in the USA is reported to be approximately 42%. Of these about 40% are perennial, 20% are strictly seasonal and 40% are mixed (perennial with seasonal exacerbation). Virtually every child has bouts of increased nasal congestion and rhinorrhea that may lead parents to question whether their child has allergic rhinitis. Hear about the different types of allergic rhinitis of childhood and the features that distinguish allergic rhinitis from other causes of childhood rhinitis. A practical approach to treatment will be discussed, including allergen avoidance, pharmacotherapy, and when to consider referral to an allergist for the consideration of allergen immunotherapy.

A5 Chronic Thromboembolic Pulmonary Hypertension: Diagnosis and Treatment Approaches 25% Rx

Chronic thromboembolic pulmonary hypertension (CTEPH) results from inadequate flow restoration of the pulmonary circulation after pulmonary thromboembolism. . If untreated, patients with CTEPH have a mean life expectancy of less than three years. Fortunately, a number of effective treatments are now available including a surgical cure for proper candidates, as well as FDA approved medical pharmacotherapy for those with inoperable or post-surgical residual CTEPH. Gain a better understanding of both pulmonary hypertension in general, and more specifically, CTEPH. Guideline directed approaches to these diagnoses will be discussed, including management, as well as when/how to make a prompt and appropriate referral to expert treatment centers.

B1 A Practical Approach to Unusual Pain Syndromes and Clinical Conditions 25% Rx

L3 Evidence Based Evaluation and Treatment of Pulmonary Sarcoidosis 25% Rx

Pulmonary sarcoidosis is among one of the most challenging autoimmune diseases, however, when diagnosed in early stages complete remission is attainable. Studies have shown that at least three office visits generally occur prior to diagnosis of sarcoidosis, during which the disease may continue to progress to the point of requiring oxygen and pulmonary rehab. When the disease is diagnosed while in Stages I or II, there is a greater than 60% remission rate. If the symptoms are worked up sooner, the patients generally will only require courses of steroids for stabilization. Gain knowledge of appropriate diagnoses in evaluating patients presenting with respiratory symptoms.

Genitourinary syndrome of menopause (GSM), formerly known as atrophic vaginitis, has a significant negative impact on a woman's quality of life. While vasomotor symptoms of menopause eventually resolve, GSM persists and worsens with time. Common symptoms of GSM include recurrent urinary tract infection, vaginitis, and dyspareunia. Women frequently do not recognize these symptoms as being related to menopause and are often resistant to effective treatment strategies for GSM. Many providers do not

understand that GSM impact goes beyond symptoms of vaginal dryness and are unsure of how to appropriately treat this common condition. Hear how to recognize, treat, and communicate with patients about this condition.



P5 The Diagnosis of Attention Deficit Hyperactivity (ADHD) in Children: Let's Sleep on It! — Importance of the Evaluation of Sleep Disorders when Considering ADHD 0% Rx

Children with insufficient sleep often have symptoms of hyperactive behavior and behavioral problems, which can be similar to symptoms of Attention Deficit/Hyperactivity Disorder (ADHD). Sleep problems are experienced by 14% to 27% of children. These problems can range from occasional nighttime difficulties to obstructive sleep apnea or periodic limb movement disorder. Understand how to distinguish the symptoms of behavior problems from symptoms of sleep problems. All children need to be assessed for complaints about snoring, mouth breathing, or restless sleep.

R2 The Top Three Endocrinology Issues of 2016 75% Rx

Hypothyroidism, Osteoporosis and Male hypogonadism are common endocrine conditions. However, significant controversy exists over when to treat these conditions, what medications most effectively and safely treat them, and the long term benefits and safety of the medications used. Treatment of hypothyroidism is straightforward in many patients, but there is significant controversy over treatment in certain situations such as pregnancy, the elderly, in patients who have persistent symptoms on standard thyroid hormone replacement therapy. There are now numerous medications approved for the treatment of osteoporosis. Significant controversy remains, however, over calcium and vitamin D nutrition, the optimal choice of medications, and the prevention of medication induced atypical femoral fractures and osteonecrosis of the jaw. Hypogonadism is an clear indication for testosterone replacement therapy; nonetheless important issues remain over when to start androgen replacement therapy, long term benefits and risks of treatment.


