





The Medicare Access and Chip Reauthorization Act (MACRA) calls for a foundational shift in Medicare reimbursement from a fee for service (quantity) based model toward one which incentives and rewards high quality, high value care. NPs are uniquely qualified to succeed in these models, without any sacrifice to the personalized care they deliver. However, they generally lack the knowledge and resources necessary to structure their practices to take advantage of these opportunities. Additionally, the most significant changes in the 20 years of evaluation and management are coming. Are you prepared? NPs may be at risk and need to understand the ramifications of health care fraud, be able to identify scenarios which could lead to jail, fines and loss of participation in government health care programs.

The need for medical therapy beyond medical nutritional therapy is increasing, and thus the need for medical management of hyperglycemia. As insulin is the preferred first-line therapy, it will become necessary for midwives and women's health nurse practitioners to identify these women and become comfortable in the management of medical therapy.


